## What is this product?

### Type

This is an investment fund established as a Company With Variable Capital (SICAV).

### Objectives

**Investment objective** The sub-fund aims to achieve a high level of income as well as capital growth, predominantly through a diversified portfolio of MENA (Middle East & North Africa) debt securities of varying maturities along with cash and cash equivalent instruments such as money market funds with efficient portfolio management. The sub-fund may also take on exposure to issuers outside the MENA region.

**Investment policies** For this purpose, the sub-fund:

- invests up to 100% of its assets in fixed and floating rate securities which shall be principally, but not limited to, MENA markets;
- may take exposure to non-MENA securities up to a limit of 30%;
- may hold cash and cash equivalents;
- may invest in collective investment schemes.

The sub-fund will not invest in any underlying fund with an annual management fee in excess of 2%.

The sub-fund may invest in financial derivative instruments for hedging purpose.

**Benchmark** The Sub-Fund is managed actively and uses the JP Morgan MSCI GCC Total Return index as a universe to select securities from. The deviation of the portfolio composition of the Sub-Fund compared to the benchmark is material.

**Redemption and Dealing** Investors may subscribe, convert and redeem shares on demand on a daily basis, being a valuation day, as further determined in the prospectus of the fund.

**Distribution Policy** Income generated may be distributed.

**Launch date** The sub-fund was launched on 28/07/2014. This share class was launched on 06/09/2017.

**Fund Currency** The reference currency of the sub-fund is USD. This share class currency is GBP and it is fully hedged against a change in currency exchange rates of the reference currency of the sub-fund.

**Switching between Funds** Shareholders have the right to convert all or part of their Shares of any Class into Shares of the same Class in another sub-fund or into Shares of another existing Class of the same or another sub-fund by applying for conversion in the same manner as for the issue of Shares. However, the right to convert Shares is subject to compliance with any conditions (including any minimum subscription amounts) applicable to the Class into which the conversion is to be effected.

### Intended retail investor

This product is intended for investors who plan to stay invested for at least 5 years and are prepared to take on a medium-low level of risk of loss to their original capital in order to get a higher potential return. It is designed to form part of a portfolio of investments.

### Term

The Fund is open-ended and has no maturity date. Subject to the liquidation, dissolution and termination rights of the Board of the Fund as set forth in the Fund prospectus, the Fund cannot be automatically terminated. The manufacturer, Emirates NBD Asset Management Limited, is not entitled to terminate the product unilaterally.

## What are the risks and what could I get in return?

### Risks



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 3 out of 7, which is a medium-low risk class.

### Performance scenarios

### What happens if the sub-fund is unable to pay out?

If we are not able to pay you out what we owe you, you are not covered by any national compensation scheme. To protect you, the assets are held with a separate company, a depository. Should we default, the depository would liquidate the investments and distribute the proceeds to the investors. In the worst case, however, you could lose your entire investment.

### What are the costs?

#### Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- in the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario,
- 10,000 GBP is invested.
