What is this product?

Type

This is an investment fund established as a Company With Variable Capital (SICAV).

Objectives

Investment objective The sub-fund is a fund of funds. The sub-fund will seek to provide investors with a professionally managed means of participating directly or indirectly in investments across a range of asset classes including, but not limited to, equities, fixed income, real estate, money market, commodities and alternative strategies with the aim of providing long-term capital growth, while seeking to preserve capital over 7 years period.

Investment policies The sub-fund may:

- Hold units or shares of collective investment schemes (including exchange traded funds).
- Invest up to 85% of its assets in global equity, up to 100% of its assets in fixed income and cash and up to 40% of its assets in alternative strategies, only through collective investment schemes.
- Diversify its investments across a range of asset classes with a majority of the sub-fund's assets invested in collective investment schemes predominantly offering exposure to a range of equities and fixed income strategies as well as other asset classes that the Investment Manager perceives to be consistent with the mandate of the sub-fund. The sub-fund may also take indirect exposure through collective investment schemes to other asset classes including but not limited to commodities, real estate and alternative strategies always in a manner allowing the sub-fund to monitor the above exposure.
- Permit hedging to protect the USD value of the investments.

Additionally, for efficient portfolio management and in order to meet redemption requests each Share Class may, where practicable, retain in cash or other readily liquid assets.

No underlying fund will be purchased with an annual Management Fee greater than 2%.

Benchmark The Sub-Fund is managed actively without reference to any benchmark.

Redemption and Dealing Investors may subscribe, convert and redeem shares on demand on a daily basis, being a valuation day, as further determined in the prospectus of the fund.

Distribution Policy Income generated will be reinvested.

Launch date The sub-fund was launched on 09/09/2020. This share class was launched on 22/04/2021.

Fund Currency The reference currency of the sub-fund is USD. This share class currency is EUR and it is fully hedged against a change in currency exchange rates of the reference currency of the sub-fund.

Switching between Funds Shareholders have the right to convert all or part of their Shares of any Class into Shares of the same Class in another sub-fund or into Shares of another existing Class of the same or another sub-fund by applying for conversion in the same manner as for the issue of Shares. However, the right to convert Shares is subject to compliance with any conditions (including any minimum subscription amounts) applicable to the Class into which the conversion is to be effected.

Intended retail investor

This product is intended for investors who plan to stay invested for at least 5 years and are prepared to take on a medium-low level of risk of loss to their original capital in order to get a higher potential return. It is designed to form part of a portfolio of investments.

Term

The Fund is open-ended and has no maturity date. Subject to the liquidation, dissolution and termination rights of the Board of the Fund as set forth in the Fund prospectus, the Fund cannot be automatically terminated. The manufacturer, Emirates NBD Asset Management Limited, is not entitled to terminate the product unilaterally.

What are the risks and what could I get in return?

Risks

Performance scenarios

What happens if the sub-fund is unable to pay out?

If we are not able to pay you out what we owe you, you are not covered by any national compensation scheme. To protect you, the assets are held with a separate company, a depository. Should we default, the depository would liquidate the investments and distribute the proceeds to the investors. In the worst case, however, you could lose your entire investment.

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- in the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario,

- 10,000 EUR is invested.
